Enhancement: PM Messages are Now in Compliance with Section 508

Under Section 508 of the Rehabilitation Act, agencies must give employees with disabilities and members of the public access to information that is comparable to the access available to others.

Privilege Management for Windows messaging now meets the compliance mandates for accessibility requirements for information and communication technology (ICT), through compatibility with screen reader and accessibility tooling.

# **New in Privilege Management Cloud**

Enhancement: Web Policy Editor Rule Script Management

In Privilege Management, a Power Rule is a PowerShell-based framework that lets you change the outcome of an Application Rule, based on the outcome of a PowerShell script.

Rather than a fixed default rule that can be set to Allow, Elevate, Audit, or Block for the applications in the targeted Application Group, a Power Rule lets you determine your own outcome based on any scenario you can build into a Power Shell script.



In 22.5, BeyondTrust introduces the ability for users to upload, view, and delete Power Rules within the Web Policy Editor, improving ease of use and providing users with additional flexibility in managing Power Rules.




Figure 1 – Upload, View, and Delete Power Rules within Web Policy Editor

#### Enhancement: Add Variable Substation to Mac Messages

In 22.5, BeyondTrust introduces the ability for customers to add more message variables like "[PG\_APP\_DEF] - The name of the Application Rule that matched the application" as an example to Mac Messages. Through the BeyondTrust Ideas Portal, customers requested the ability to add additional information within Privilege Management Mac Messages. The enhancement delivers on this request and allows users to communicate more information through the mac messaging.

The team is currently working on adding additional options in future releases, which include the addition of URL/hyperlinks in the messages.
