DevOps Secrets Safe is a Command Line Interface tool used to secure and manage secrets used by apps and other non-human identities in the CI/CD tool chain.

Evaluation Methods Used

Assistive technology products used as part of testing included Freedom Scientific JAWS 2020, NVDA 2020.1, Freedom Scientific ZoomText 2020, Dragon NaturallySpeaking 13, Microsoft Windows accessibility features, and keyboard-only control. Testing was performed on Windows 10 using Windows Subsystem for Linux (WSL).
